The undersigned acknowledges and agrees that any annual fees paid to the club shall not be refundable unless the undersigned is not approved for an Annual Pass. Payments will be via Check, Debit, or Credit Card.

Split Payment Option: A Split Payment Option is available for Annual Passes at the clubs. The Initial Payment will be equal to ½ the annual classification, plus a **Split Payment Convenience Fee of \$35.00**, and is due upon application. **The remaining payment is due on or before 1 Apr 24.**

Availability Period: The Annual Pass at both Clubs ***begins on 1 Jan 2024 and concludes on 31 Dec 2024.*** Prorations of Golf, Family Add-On, Junior, and Practice Range shall be based on a seven (7) month golf season defined as 1 April through 31 October.

Privileges for Annual Pass Holders: Allows the individual to use the golf and clubhouse facilities provided at both clubs and to attend Club Sponsored events held at both, upon payment of the applicable fees, dues, and other charges established by the Club. Annual Pass Holders shall not be charged green or cart fees for use of the golf facilities but shall pay for the use of additional amenities and charges established by the club. Annual Pass Holders will enjoy an advance reservation privilege for golf starting times established by the club. Additional amenities available include Practice Range, Private and Group Golf Lessons, Junior Golf Camps, Member-only Golf and Social events, Discounts on Golf Shop items.

- *Full and Limited Passes will be provided a GHIN by the USGA for Handicap Services from application until 31 Dec 2024*
- *Full and Limited Passes will have access to a "Member's Only" Tee Sheet Portal for advanced reservations*
- *Full and Limited Passes includes the use of the Practice Range*
- *All Passes include Mill River Pricing in the Golf Shop*
- *All Passholder Owned Carts at the CTGC will carry "CTGC Member 2024" stickers or they will not be permitted on the CTGC Course*
